

Weather Defense® Platinum High Performance Exterior Sheathing
LIMITED WARRANTY

Continental Building Products provides the following limited warranty for Weather Defense® Platinum High Performance Sheathing, subject to the conditions and limitations specified below:

Weather Defense® Platinum

(1) will be free of manufacturing defects that make it unsuitable for its intended use for a period of five (5) years commencing on the date of purchase; and

(2) will not decay as a result of exposure to incidental moisture or normal weather conditions as contemplated by the normal use of Weather Defense® Platinum for a period of twelve (12) months commencing on the date of installation of Weather Defense® Platinum on a structure.

In the event that Weather Defense® Platinum does not perform in the manner described above, and subject to the Conditions and Limitation of Warranty stated below, Continental Building Products will reimburse the original installing contractor for the structure in which Weather Defense® Platinum was installed as new construction in an amount up to a maximum of two (2) times the original uninstalled purchase price of the nonconforming Weather Defense® Platinum for the cost of repair or replacement of the nonconforming Weather Defense® Platinum. Any cost or expense beyond this amount shall not be the responsibility of Continental Building Products. (As used hereinafter, "Continental Building Products" includes its subsidiaries and corporate affiliates, as applicable.).

Conditions and Limitations of Warranty:

(1) This warranty is personal to the original installing contractor for the structure on which the Weather Defense® Platinum was installed and is not assignable or transferable under any circumstances. Continental's obligations under this warranty shall terminate no later than five (5) years from the date of sale of the Weather Defense® Platinum to the installing contractor.

(2) Continental Building Products must be given reasonable opportunity to inspect any claim under this limited warranty prior to incurring any obligation hereunder and Continental Building Products shall not be liable for any cost, repair or replacement that is not pre-authorized in writing by Continental Building Products. Any and all claims must be proved and made in writing within thirty (30) days of the discovery of the defect to:

(3) This warranty is not valid and Continental Building Products shall not be liable for any damages if Weather Defense® Platinum was not stored or installed in accordance with Continental Building Products storage and installation instructions, standard building practices and all applicable building codes. (4) This warranty is not valid and Continental Building Products shall not be liable for any damages incurred if any material or component involved in the original installation of the Weather Defense® Platinum was modified in any way, including the repairing or replacing of any cladding or coating systems, finishes or other surface covering.

(5) This warranty is not valid and Continental Building Products shall not be liable for any damages incurred if the Weather Defense® Platinum, during or after installation, was subject to conditions other than those of normal weather or use conditions, such as improper handling, misuse or abuse after installation, impact of falling objects, persistent water contact (including but not limited to, cascading roof/floor water, ponding water or immersion in water), vandalism, earthquake, hurricane, tornado, fire, other acts of God, and failure or distortion of a wall or the foundation of the structure (including but not limited to settling of the structure or movement of framing members). This warranty also excludes any claim relating to the development of mold, mildew, bacteria or other similar organisms in, on, or alleged to be caused by the Weather Defense® Platinum.

(6) This warranty is not valid and Continental Building Products shall not be liable for any damages incurred if any materials or components involved in the Weather Defense® Platinum installation are (deemed by Continental) incompatible, including any cladding or coating system, finishes or wall covering applied over the Weather Defense® Platinum. The installing contractor is responsible for obtaining all approvals for suitability and compatibility from the cladding or coating-system, finish, or wall-covering manufacturer prior to application.
